FOREST FOR MONARCHS - service accomplishments over the past year (during 2019): 300,000 native tree seedlings were purchased from Forests for Monarch's Mexican nursery partner and planted with local people and organizations that also received technical assistance. These new trees planted for forest restoration and monarch butterfly habitat conservation also provide erosion control, watershed restoration, and a source of wood. Sixty percent of the trees were planted around the Monarch Butterfly Biosphere Reserve, and the remaining was planted in the area around Lake Patzcuaro and Zirahuén, Michoacán, Mexico. These new trees helped to reforest over 275 ha (667 acres) this year.
