# DIRECTOR'S STATEMENT

2019 was a steady year for Forests for Monarchs. While our tree numbers dropped slightly, we were still able to plant 300,000 trees in highneed areas around the Monarch Butterfly Biosphere Reserve area and surrounding communities, in addition to the Highland Lakes Watershed Region. Our numbers dipped slightly because projects outside of the United States are no longer eligible for a specific National Fish & Wildlife Foundation grant we were previously eligible for - we are grateful for the years of support from the agency. If anything, this gives us a new and exciting challenge in finding sustainable funding that will ensure the longterm success of this program. Because the reality is that the need for trees is high, and even planting 300,000 and 400,000 trees a year does not meet that need. As an organization heading into 2020, we're going to start focusing on you the donor - to join us in our mission and help ensure the survival of this important species and the protection and rehabilitation of crucial forest land.



### MONARCH HEALTH & POPULATION IN 2019

This year (2019-2020), monarchs are having a tough time. The western population was reported at less than 1% of its original size. The eastern monarchs – those that migrate to Mexico each year – experienced a 53% decrease in population size from the previous year. The decline for the eastern monarch can be attributed to deforestation in Mexico, ongoing widespread herbicide use in the United States, reproduction issues in March and April due to colder temperatures, late migrations to Mexico in the Fall of 2019, and drought. The uptick in monarchs seen in New England and some of the more northern Midwest states in the summer of 2019 did not correlate to a higher population count at the monarch winter sites.
